

## INFORMATION ABOUT THE USE OF COOKIES

This document describes the use of cookies in linnk.app website and application, indicates their purpose, as well as the users' rights to choose the use of the cookies in compliance with their needs.

Cookies allow the provision, improvement and protection of mobility.delivered services, ensuring solutions that are best suited for the client's needs, as well as a more convenient and secure experience for the user.

### What are cookies?

Cookies are small text files that are saved by the web browser (for example, *Internet Explorer, Firefox, Google Chrome, Safari etc.*) in the web user's computer, tablet or smartphone. When cookies are used, the websites and applications can also save individual users' settings. Cookies typically contain information about the website or application name, their storage life on the device, and their unique number. Cookies can be considered as a way for a website or application to obtain information that allows the user to be recognised and responded to appropriately. The user can disable or limit the use of cookies; however, without the cookies, full use of the site's functions will be restricted.

### What cookies are used by LINNK and what are their purposes?

The link.app website uses several types of cookies. They vary according to their purpose and storage length. The cookies are gradually renewed and adapted to the needs of improving the quality of service provision.

The main purposes of the cookies are the following:

- *To authenticate the user* – ensures recognition of the user.
- *To provide and maintain services* – cookies that functionally support provision of mobility.delivered services.
- *To ensure internet site security and service integrity* – cookies that help create services, ensuring a better customer experience and safer use of the internet site.
- *To ensure statistics and analysis of usage* – provides information how and how often the LINNK internet site, application and e-mobi application is used and what search tools are used. Cookie statistics can also be obtained from cooperation partner internet sites.
- *To offer services and analyze customer needs* – cookies ensure development of offers that are best suited for the customers' needs.

### **Third party cookies**

The linnk.app website can use the information of third-party cookies. The user may also be given the most suitable offers in internet resources of cooperation partners. For this analysis, the following tools are used:

- **Google inc.** tools **Google Analytics, Doubleclick, Google Tag Manager and GA Audiences.**

### **How can a user choose and change the use of cookies?**

If you do not want your devices to use cookies, you can change the security settings of your browser or select it in the LINNK application settings. Note that security settings must be changed for each browser separately and the user setting methods can vary for different browsers and for different versions of browsers.

However, remember that without approving cookies in the linnk.app web site, you cannot fully use mobility.delivered services.

### **Cookie management**

Most web browsers are initially set to automatically accept cookies. You can change the settings to block cookies or receive alerts when cookies are sent to your device. Read the browser usage instructions or open the help screen to learn more about how to change your browser settings.
